PROCEDURE FOR SUBMITTING MATERIAL TO THE JOURNAL AND ARTICLE REQUIREMENTS

- 1) The material proposed for publication shall be original and not previously published. No more than one single author's article and one co-author's article are accepted for publication in the issue at the same time.
- 2) Works of students are not accepted. Articles of undergraduates and doctoral students are published if there is a positive review of the scientific director. The editorial board of the scientific journal reserves the right to select articles for publication. Selection criteria: scientific and practical relevance and conformity to the requirements for design.
- 3) The scientific article signed by the author shall be made available to the Editorial Board in electronic form.
 - 4) Drafting requirements:
- the manuscript text is provided in Microsoft Word for Windows *.doc format, page size A4;
 - orientation book, no page numbering, no hyphenation;
 - fields: right, left, top, bottom 2.0 cm;
 - Times New Roman font;
 - pin 14;
 - line spacing 1;
 - 1 cm indent in paragraph;
 - information about the author(s) (in Kazakh, Russian and English):
 - last name, first name, patronymic of the author(s) (in full);
 - the place of work, the position of the author(s);
 - academic degree, academic rank;
 - contact information (e-mail, mob. and slave. phones).

The scientific article should contain:

UDC (universal decimal classifier);

- the title of the article (in Kazakh, Russian and English);
- annotation (summary of work, conclusions, not less than 80 to 100 words) (in Kazakh, Russian and English);
- keywords (at least 8 words) (in Kazakh, Russian and English);
- bibliographic list (at least 5);
- article-by-article bibliographic links, decorated in accordance with the GOST «Bibliographic link»;

- Fundamentals.

Set out in a sequence of parts of the article and includes:

- Introduction.

The relevance of the topic or problem is analyzed. The purpose and objectives of the study are indicated. The relevance of the topic is determined by the development of modern society, the needs of the development of legal science and legal practice.

- Materials and methods.

When writing articles should use theoretical and practical methods of research. The choice of research methods is an important stage in the writing of a scientific article, as they depend on the quality and reliability of the results. Comparative historical analysis can be used when using international instruments, foreign and national legislation and other sources.

- Results, discussion.

The results of the study are compared with previous studies, and generalizations are made on the basis of new results.

- Conclusion.

Conclusions are drawn, recommendations are made to improve the problems under consideration, the scope of application is indicated.

List of References.

The list is at the end of the article. References should be numbered strictly in the order of mention in the text. The reference number in the article is in square brackets. The first reference to literature in the text should have the number [1], the second [2] and so on. The reference to the book in the main text of the article should be accompanied by an indication of the pages used (for example [2, 545 p.]).

Electronic resources that do not include the author of the material, statistical collections, legal acts are listed in footnotes and are not included in the list of used literature.

When the source is repeated, it is assigned the initial citation number. Links to Internet resources indicate the author, title of the text, source, full e-mail address of the material, date of its visit. Link to private messages, reports, unpublished dissertations and other unpublished materials is not allowed. - text alignment by width;

- manuscript volume 8-10 pages of the specified format.
- the title of the article in the center, without indentation, capital letters;
- use Microsoft Office Software Package Formula Editor.
